Report submitted prior to meeting:

- Trustees, SPR, Staff, CMK met to work out a more comprehensive plan for Facilities and Cleaning to address gaps and concerns.

Trustees Scott Gillispie

Report submitted prior to meeting:

The primary issue for the Admin Board to be aware of is that Trustees work is significantly over budget this year; with a project budget of \$10,000, so far we have spent over \$11,000 on HVAC repair, as well as \$10,000 on resolving the drainage issues, over \$20,000 on flooring, as well as projects we believe are supportive of the use of the church and grounds (such as the new water fountains. I am working with the Finance Committee to both make sure we are able to cover the

costs for necessary repairs, as well as identify funding sources for upcoming priorities from undesignated giving. In addition to covering these current costs, we will also need to look at updates to the budget amount for future years, as well as identifying specific needs that can be called out as part of the stewardship campaign.

The following key activities are currently being worked on by the Trustees:

- Leak / drainage issues in courtyard Aquaguard was working in the Fellowship Hall during the week of August 9; a new sump pump was installed, and new drainage installed in the concrete floor. In addition to work that Jacob has managed in getting storm drains cleared; we believe we have taken the initial set of steps required to remedy the ongoing drainage and flooding issues. There are a number of follow on issues, including cleanup, paneling to cover the new vapor barrier on the walls, and replacements for water damaged baseboards.
- Fellowship Hall Flooring The Trustees are focused on installing a vinyl plank or tile floor to replace the worn-out carpet tiles in the Fellowship Hall. The initial estimate is \$18,500 installed, although there will be additional requirements to finish the room (such as baseboards, as noted above).
- Georgia Power tree trimming Georgia Power has completed their work, several limbs remain behind the Scout Hut sign.
- Water fountains Water fountains with bottle fillers have been installed on the nursery hall downstairs and the classroom hall upstairs. Upgrading the remaining water fountains will be identified as a target for future action, as new budget dollars are available.
- Outdoor pavilion Russ Dunlap and the Men's Committee have completed their initial shelter installation. If we decide to install a larger shelter in the future, this 12' by 20' shelter can be relocated on the property.
- Front desk team we need to re-establish the coverage, with two volunteers each Sunday morning for early / late services. Organizing this is pending action by Trustees.
- Bridge inspection We have asked Finance to allocate funding for a formal inspection of the entry bridges this year, so we have an estimate on work required and cost.
- Give for the grounds funding The Finance Committee has notified us that \$4500 has been collected based on the Give for the Grounds signs on the property, with the bulk of that coming from non-congregation members. Beyond coverage of the ongoing grounds maintenance, these funds can be drawn on to cover the costs of bringing goats on the property for clearance of kudzu and brush, as well as installing two dog waste stations. An additional note for long term planning: The Recreation Committee has approached Trustees about expanding the disc golf course, in addition they have approached the city of Chamblee to expand the course on lots in the Gainsborough neighborhood condemned several years ago as part of flood plain changes. This resulted in an initial meeting last week between Trustees, Rec Committee, and City staff. The focus of the conversation from the city side is that their master plan includes extending a multi-use trail across the church property, from Chamblee Dunwoody Rd, along the creek line, and onto city property along the creek behind Savoy Dr. The city is secondarily focused on preserving existing greenspace such as the woods on the church property, either through purchase or a conservation easement. Part of the priority of completing a bridge inspection is to support ongoing conversations with the city. In addition to physical changes to the property, impact on security due to this additional access will be a key topic in ongoing discussions with the city.
- Following Scott Gillispie's review of highlights, Scott Pirnie inquired about the \$22k in designated funds
